## PRIVACY POLICY TO MEMBERS

PURSUANT TO ART. 13 OF REGULATION (EU) 2016/679 (so-called GDPR)

**The Data Controller is the KUNPEN LAMA GANGCHEN Association,** with registered office in Via Marco Polo, 13 - 20124 Milano (MI) and administrative office in Via Campo dell'Eva, 5 - 28813 Albagnano di Bèe (VB), C.F.: 97216720157, P.Iva. 12457970155, Registered at the Milan Registry Office protocol No. 004646 of 23/02/1998. The Data Controller uses the personal data communicated at the time of registration with the Association or communicated subsequently for the following purposes

- pursuit of the Association's purposes

- management and storage of membership forms

- contacts between members and the Association (including through on-line tools);

- promotion of the Association's activities, including through newsletters, printed and on-line publications. Upon request, the interested party may be included in the Association's whatsapp groups for communication of events and/or news. or for inclusion in WhatsApp groups for communication of events and news. Please note that this number will be visible to all members of the groups and that the Association cannot therefore guarantee its confidentiality or proper use by other members.

The data of members of the Association are processed by the Association on the basis of the consent of the person concerned, given with the application for membership (cf. Art. 6(1)(a) GDRP). The consent may be revoked at any time, without the revocation affecting the processing carried out prior to the revocation. In the case of a member who is a minor, consent is given by the parents and the registration is valid until the member reaches the age of majority, unless revoked by the parents.

The processing is also carried out within the scope of its legitimate activities (cf. Art. 9(2)(d) GDPR) and for the fulfilment of contractual obligations (cf. Art. 6(1)(b) GDPR).

The processing is carried out by the Association, by means of the internal persons in charge specifically instructed by the Data Controller and by external persons duly identified and appointed as data processors.

Where possible in accordance with the purpose of communication/dissemination, data will be processed in anonymous and aggregate form (e.g. communication of data for statistical purposes).

The personal data of members may be disclosed to third parties only and exclusively within the scope of the Association's activities or in fulfilment of legal obligations (cf. Art. 6, c. 1, lett. c) and Art. 9, c. 2, lett. b) GDPR) or at the request of the data subject. The subscriber's data may be disclosed only and exclusively for reasons pertaining to the statutory purpose of the Association and in any case with the subscriber's consent.

The data will be kept for 10 years, determined in accordance with Art. 2220 CC and in accordance with the period for the ordinary limitation of rights. Data will not be transferred to countries outside the EU or which do not guarantee GDPR compliance.

**RIGHTS OF THE INTERESTED PARTY**: In addition to the possibility of taking legal action or lodging a complaint with the Data Protection Authority, at any time, if the prerequisites are met, the user may exercise the Rights pursuant to Articles 15 et seq. of Regulation 679/2016 (summarised below), by contacting the Data Controller or the Data Protection Officer at the contact details indicated above.

- Right of access (Art. 15 GDPR). Right of the Data Subject to obtain from the Data Controller confirmation as to whether or not personal data concerning him or her is being processed and, if so, to obtain access to that data;
- Right of rectification (Art. 16 GDPR). Right of the data subject to obtain from the Data Controller the rectification of inaccurate personal data concerning him/her, without undue delay. If the data provided is incomplete, it may be supplemented by the Data Subject by means of a supplementary declaration;
- Right to erasure (Art. 17 GDPR). The Data Subject has the right to obtain from the Data Controller the erasure of
  personal data concerning him/her without undue delay. In this case, the Controller shall have the consequent
  obligation to delete such data without undue delay;
- Right to restriction of processing (Art. 18 GDPR). Right of the Data Subject to obtain a restriction of the processing in certain cases: the data subject contests the accuracy of the personal data; the processing is unlawful and the data subject objects to the deletion of the data, requesting instead its restriction; the personal data is necessary for the establishment, exercise or defence of a right in a court of law; the data subject has objected to the processing, pending verification of whether the data controller's legitimate reasons prevail over those of the data subject;
- Right to data portability (Art. 20 GDPR). The Data Subject has the right to receive the personal data concerning him or her provided to the Data Controller and has the right to transmit such data to another data controller without hindrance from the Data Controller in cases where: a) the processing is based on consent pursuant to Art. 6(1)(a) or Art. 9(2)(a), or on a contract pursuant to Art. 6(1)(b) the processing is carried out by automated means;
- Right to object (Art. 21 GDPR). Right of the Data Subject to object to the processing of his/her personal data.
